Chad served survivors of the 2013 thru 2018 Oklahoma disaster events helping them through some of the most difficult times in their lives. Together with other staff members and partner organizations he assisted us in developing an effective disaster recovery organization for the Oklahoma United Methodist Church.

Chad was hired by OKUMC-DR in 2014 for what we believed would be a two year "temporary" position, but the major devastation of the 2013 storms and the statewide flooding of 2015 created difficulty in project and volunteer coordination resulting in a longer Recovery. In addition, 2015 and 2016 both brought tornado events to Tulsa and other towns in NE Oklahoma and each disaster extended the need of those temporary staff members. We were blessed by receiving significant funding during the 2013 event which enabled us to continue to restore lives that we would not have been able to do otherwise.

Since the end of 2016, for the most part, we have been in a "Blue Sky" time period when disasters have been few and far between, and so has the funding for our ministry. Because of the reduced funding OKUMC-DR is having to restructure back to its pre-2013 staff and disaster ministry structure. This reduction has nothing to do with the performance of Chad and/or the other staff members who will be released from employment on October 31, 2018.

The reduction in our ministry is very disappointing, but the impact Chad and the other staff members have made will be remembered for years to come. They leave a lasting mark on Oklahoma communities, on the lives of hundreds of disaster survivors, and on the thousands of volunteers who continue to return because of the experience they received.
